4a (Code:) (Expenses \$ including grants of \$) (Revenue \$) IN MARCH 2020, THE FUND FOR PPS ESTABLISHED THE CORONAVIRUS RELIEF FUND TO RESPOND TO THE EMERGING NEEDS OF PPS STUDENTS AND FAMILIES DURING THE WORLDWIDE PANDEMIC THAT PLUNGED PPS INTO UNPRECEDENTED TIMES. CREATING A VEHICLE THROUGH WHICH DONORS COULD GIVE TO SUPPORT THE PPS COMMUNITY, WE WERE ABLE TO RAISE FUNDS AND PROVIDE EMERGENCY RELIEF TO FAMILIES FACING MULTIPLE BARRIERS.

BY JUNE 30, 2022, THE FUND FOR PPS DISTRIBUTED \$1.1 MILLION IN SUPPORT TO PPS FAMILIES MOST IN NEED AS WELL AS TO PARTNER SUPPORT PROGRAMS. THIS IS A QUICK SNAPSHOT OF HOW WE'VE SERVED:

USING JUST TWO DATA POINTS ENABLES US TO IDENTIFY THE SCHOOLS WITH THE GREATEST NEED FOR AN AWARD AND PROVIDE CLEAR TRANSPARENCY.

THERE ARE OVER 100 HIGH SCHOOL STUDENTS WHO TAKE THE CLIMATE JUSTICE ELECTIVE EACH YEAR, AND A CLIMATE JUSTICE YOUTH ADVISORY MEETS REGULARLY AND ADVISES THE DISTRICT ON ISSUES OF GREAT IMPORTANCE TO THEM AND THEIR FUTURES. STUDENTS ARE INVOLVED IN GREENHOUSE GAS (GHG) EMISSIONS CONVERSATIONS, AND DESIGN DECISIONS ABOUT THEIR SCHOOL GROUNDS THAT CAN INCLUDE DEPAVING AND TREE PLANTING. THIS WORK WILL CONTINUE TO EXPAND AS THE PPS SCHOOL DISTRICT PASSED THE CLIMATE CRISIS RESPONSE IN MARCH 2022, PAVING THE WAY FOR REDUCING GHG EMISSIONS AND BEING CARBON-NEUTRAL BY 2040.

THE DECISION OF THE BOARD ON THESE MATTERS WILL REST IN THEIR SOLE DISCRETION, AND THEIR CONCERN MUST BE THE WELFARE OF THE FUND FOR PPS AND THE ADVANCEMENT OF ITS PURPOSE.
